Waiver, Medical Power of Attorney, Authorization and Acknowledgements

The owner or authorized agent of the owner named above (the "owner") of the dog named above (the "dog"), does hereby release, indemnify and forever hold harmless BARKZ the dog stop, LLC, a Washington limited liability company ("BARKZ"), its employees, officers, investors, agents, subcontractors, customers, visitors, guests, successors, and assigns, from and against any and all liabilities (including attorney's fees) arising out of or connected with injuries, illness, loss, damage or other harm to myself, my dog, my property, my guests or invitees which arise in any way out of services or products provided by BARKZ or as a consequence of my membership in, association with, or use of the facilities of, BARKZ.

The owner hereby acknowledges that dogs are unpredictable in behavior, and understands that injuries to the dog, the owner, and the owner's guests might reasonably be foreseen to result from the dog's attendance and participation with BARKZ. The owner is fully aware that BARKZ encourages off-leash socialization and interaction of dogs in its custody and care and accordingly assumes any and all risks related to owner's membership, use of BARKZ's facilities, and BARKZ's performance of its services, including but not limited to bites, bodily injury, illness and disease, theft, falls, collisions with vehicles, natural disasters and death. The Owner also agrees to assume all liabilities, costs, damages, claims and expenses that may occur as a result of the dog's actions.

If, in the owner's absence, the dog should be injured, become ill or suffer an ailment or is otherwise deemed by BARKZ to require immediate medical attention, BARKZ, in its sole discretion, is authorized to make all health care decisions on the owner's behalf, and may utilize the services of a licensed veterinarian to administer medicine or give other requisite attention to the dog at the owner's sole expense. The owner hereby indemnifies BARKZ from any action, claim, demand or lawsuit (including attorney's fees) arising out of or connected with the charges made by any veterinarian caring for the dog.

The owner hereby certifies and represents that the dog is in good health and has not been ill with any communicable condition in the last 3 months. The owner also represents that the dog is current on all vaccinations for Rabies, Bordetella, and DHLPP. The owner further certifies that the dog has not harmed or shown aggressive or threatening behavior towards any person or any other dog or animal. The owner understands that BARKZ reserves the right to refuse use of BARKZ facilities or to rescind attendance rights for any dog who, in BARKZ's sole determination, acts aggressively, is undisciplined, evidences inappropriate behavior or who might otherwise be a danger to itself, other animals or people. The owner acknowledges that all services, rates, policies and procedures of Barkz are subject to change without notice.

The owner certifies and represents that all of the information provided to BARKZ in writing or otherwise relating to the owner and the dog is true and correct. The owner will immediately notify BARKZ of any changes to what he or she has represented above.

The owner agree that his or her name and the likenesses of the dog may appear on BARKZ's website, advertising, printed materials, promotional videotapes, news programs and/or other press, magazine, radio, television and/or internet coverage from time to time.

With regard to any dispute under this contract which is not resolved through insurance, BARKZ and the owner shall first meet face-to-face without attorneys present to attempt to reach a resolution. If the dispute is not resolved in this meeting, then, upon thirty (30) days notice by either party, the parties shall meet with a mediator from the Seattle office of the Judicial Dispute Resolution Service ("JDRS"), again without attorneys present, to attempt to resolve the dispute. In the event the parties are still unable to resolve the dispute in this mediation, the matter shall be resolved by binding arbitration with attorneys present before a different JDRS arbitrator. The said JDRS arbitrator shall be selected either by the mutual agreement of the parties or, if the parties are unable to agree, by the JDRS rules. The arbitration proceedings will be conclusive and not appealable by any party, and any party to any award will be entitled to have judgment entered thereon. In the event of any such arbitration, the arbitrator will determine the prevailing party and such party shall be entitled to its attorneys' fees and costs. Each and every meeting, mediation, or arbitration hearing provided for herein shall take place in Seattle, Washington
